- b. Provision of photocopy of Death Certificate preferably from NADRA and CNIC/NICOP/POC of deceased (Colour copy).
- c. One readable and valid copy of CNIC/NICOP for Pakistani national /POC/Passport for Foreign national and Form 'B' where applicable of all legal heirs.
- d. Original Information /Intimation/Allotment/Adjustment Letter and Transfer Order are required to be deposited.
- e. In case of loss of Title documents (para 1 (d)), the procedure of issue of CTC will be carried out by one of the legal heir, through consent letter.
- f. Fingerprints and three specimen signatures of each Legal Heir on plain papers separately (for Female, right hand and for Male, left hand).
- g. One latest photograph of each legal heir duly attested.
- h. Pay Order/Bank Draft of Rs. 10,000/- in favour of DHA City, Karachi as processing fee.
- j. Inclusion of deceased's parents in legal heirs if alive otherwise their death certificates be provided.
- k. Interview of the legal heir if required.
- 1. After transfer of property in the name of legal heirs no further transaction (out of family) will be made for a period of 03 x months.
- m. In case of more than one Legal Heirs, a consent letter from all the co-sharers be attached, indicating/mentioning the address on which the correspondence is to be made.
- n. Copies of Publication of two National Daily Newspapers (one in Urdu and one in English at each place) published from Karachi and the City / Province of the deceased's residence (Specimen attached).
- o. **NOC** in case of Almt of staff (**DHA/KPT**) benefit plot.
- p. In case of single heir/ Female (s) only/ Minors as legal heirs, Two Witnesses nominated (close relatives with Original CNIC) by the legal heirs will appear before DHA designated officer and will sign affidavit under camera. OR Letter of Administration from the Court. Court Order (Original) be provided in the light of Law of inheritance of Sunni Sect (Including parents if alive and if parents are not alive then Brothers & Sisters of the deceased).
- q. All legal heirs to obtain subsidized membership (Cat 'C') for use of one time only as per size of plot, **if membership already NOT held with DHA City Karachi**.
- r. Heirship Certificate duly attested by 1<sup>st</sup> class Magistrate.
- s. NOC fee Rs. 2000/- in case of NADRA Succession Certificate.

#### 2. <u>Procedure for Processing the Documents</u>

a. Documents be submitted PERSONALLY, heirs residing outside Karachi may submit documents By Post or By Hand.

- b. Issuance of check list of documents.
- c. Provisional checking of deposited documents for its correctness, Statement of Accounts is obtained from Finance Dte DCK payable / clearance by legal heirs within one year.
- d. Resubmission of documents duly completed in all respect including Transfer processing fee by legal heir (s).
- e. Verification of death certificate from the issuing Authority by DHA City Karachi.

# 3. Upon submission of documents complete in all respect, duly check and accept case will be finalized within 15 days (Approx).

# 4. Attestation of Affidavits

- Affidavit inland be attested by Oath Commissioner/Notary Public.
- Affidavits executed abroad be attested from **authorized officer of Pak** Embassy abroad or the Consulate General.
