 - e. Two Passport Size Photographs of attorney attested by a Class-I Gazetted Officer/Oath Commissioner.
 - f. 1 X Photostat copy each of CNIC both parties.
 - g. Membership of Both Parties (Executants & Attorney).
- 2. Once the application for general power attorney has been accepted please pay the fee in the Cash Counter Accts Branch. The Cash Counter will make the necessary endorsement on the covering letter.
- 3. The applicant to deposit the application at the Reception (T&R) and obtain a receipt. The receipt will indicate the date of collection.

- 3. Before making out a Pay Order/Bank Draft please find out the outstanding dues and current rate of Fee from Accounts Branch.
